RESERVATIONS & DEPOSITS: A non refundable deposit of \$400.00 per person is required to insure your reservation. Balance is due 30 days before departure. The deposit will be refunded if the tour is canceled by IAATS. (see paragraph: REFUNDS).

Prices are final at the time of your reservation. **BALANCE PAYMENT:** *Art & Architectural Tours & Seminars* reserves the right to charge balance on supplied credit card beyond balance due date. If deposit is paid by check, tour member agrees to supply *Art & Architectural Tours* with a credit card to insure proper and timely balance payment should balance not be paid by balance due date.
